## ***Fire Safety and EMS Awards***

**Chief Ronald Mastin** is a 34 year fire and rescue veteran serving in the Fairfax County Fire and Rescue Department from 1973 to 2001, then as Fire Chief for Henrico County (near Richmond) from 2001 to 2007, and then returned as **our Chief in June** of this year. He oversees 1,350 uniformed firefighters, 325 operational volunteers and 130 civilian employees in Fairfax County. With a \$170 million annual budget and 37 fire stations to maintain he is more like a CEO of a Corporation. That Corporation happens to handle fire suppression and prevention, emergency medical services, hazardous materials abatement, technical rescue, life safety education, arson investigative services, and admin and support.

**Chief Mastin** says, “Fire-fighting recruits today must fulfill more training requirements and obtain more certifications. In addition to fire-fighting and life saving skills, firefighters must learn about hazardous materials and prepare for the dangers of terrorism, bio-terrorism, pandemic flu and other threats...” “A current challenge is to properly staff the EMS (Emergency Medical Services) ranks. About 75% of the 90,000 service calls the department responds to each year involve emergency medical services.” This is why cross-training in EMT (Emergency Medical Technician) skills is so important for all fire-fighters and having more paramedics assigned per station is priority.

**We** are so honored and privileged to have **Chief Mastin** as our Fire Chief and likewise are honored and privileged to award him the Fire Safety Commendation Medal for his years of service and continued guidance to all of Fairfax County Fire and Rescue Services.

## Fire Service Professionals and Technicians

**Katja Lancing**, like all Firefighters in Fairfax County is cross-trained in basic fire fighting skills and Emergency Medical Technician (EMT) skills. Her desire was to take these basic skills to a higher level so she plunged into the Paramedic Course of training. These increased skills (preservation of life and health under emergency conditions) are difficult to achieve for the individual, but rewarding for the general public at large.

**Katja** not only completed the course of instruction, but she had to serve an internship as a paramedic which meant being constantly evaluated and placed under pressure to exhibit those life saving skills on a daily basis. She did all this while being a Mom of two small children. She even achieved the promotion to the Technician level and serves as one of three paramedics assigned to FS #1.

The Emergency Medical Services Commendation Medal is presented to an individual who has made a contribution in the EMS field that exceeded the requirements and expectations of their job description; performance above that expected of their peers. EMS Service is evolving into a highly skilled and technical profession. Countless lives are saved each year and it is our duty to inspire and support the many selfless acts of courage and skill applied in our communities.

**Paramedic Technician Lancing** exhibits those skills and courage worthy of recognition and indeed we recognized a Paramedic Technician who is a valuable asset to FS #1, the Fairfax County Fire and Rescue Department and the citizens of Fairfax County.

### Firefighter John Loss

**T**hrough the efforts of dedicated Fire Service Professionals and Technicians covering development of equipment and techniques to detect arson, forensics, fire prevention education, Emergency Medical Treatment, etc. countless lives are saved. The Fire Safety Commendation Medal is presented to individuals for accomplishment and/or outstanding contributions in the area of fire safety and service.

**Firefighter John Loss** has spent his entire career, spanning 30 years of service, protecting human life and loss of property due to fires and chemicals. **Mr. Loss** grew up in New York City and was a member of the New York City Volunteer Fire Department in 1971.

He came to Fairfax County in 1977 and started with the Department in that same year. His nominator **Joseph Kratochvil** says, “**John** knows the streets he knows the buildings and the hazards in the buildings. This valuable knowledge is transferred in a mentoring way to new and experienced Firefighters.”

He is an expert in hazardous materials and participated in the first class taught on the subject in 1982. **John** is foremost a true Fire Safety Professional and as such insures adequate fire safety protection is available for the communities thus affecting the fire rating. Many of us in the community do not know what a Fire Safety individual contributes to, but there is one thing we all should be appreciative of and that is lower insurance rates based on the fire rating.

It is individuals like **John** and **John** himself that teaches, practices and mentors others in fire safety and Firefighting business that improves the life of the community. It was with great pleasure we presented the **Fire Safety Commendation Medal Award** and a special thank you was heard from all those he has mentored. He truly has made a difference in the lives of a new generation.

## Master Police Officer (MPO) Paul DeHaven

**MPO Paul DeHaven** is the unit commander for the Helicopter Division and has been a Fairfax County Police Officer for 13 years. **MPO DeHaven** is one of the Division's senior members and serves as a Senior Paramedic/Flight Officer. His regular assignments are enough to exhaust most of us and he provides, often on his own time, the following services to the Police, Fire, EMS, and civilian communities:

- EMT instructor for both Departments (Police and Fire)
- Police Recruit Instructor at the Fairfax County Criminal Justice Academy
- Fire Recruit Instructor at the Fairfax County Fire Training Academy
- Fairfax County Citizen's Police Academy Instructor
- Member of the National Capitol Region Emergency Response Team
- Medic providing support to the Civil Disturbance Unit and Dive Teams
- Flight Officer/Paramedic Training Instructor
- Advanced Life Support Coordinator

Maintaining no less than six instructor or coordinator certifications in the medical and law enforcement disciplines, **MPO DeHaven** has demonstrated his skills (other than instructor). He was awarded the Bronze Medal of Valor for his life saving actions involving a mortally wounded Pentagon Police Officer. He also participated in the life saving efforts during the medevac of Detective **Vicky Armel**. This is in addition to the countless number of medevacs of seriously injured citizens and apprehensions of felony suspects. There is no doubt he is performance conscious.

**Fairfax Resolves** is proud to present and honor **MPO Paul DeHaven** the Law Enforcement Commendation Medal. He has served with distinction and devotion in the field of law enforcement and public safety and demonstrates the highest standards of professional excellence.

### Detective Douglas Comfort

Thirty-three years ago, Detective Comfort began his law enforcement career. After twenty-four years he retired into civilian life only to realize his burning desire was to continue his career in law enforcement. He joined the ranks of the Fairfax County Police Department. The tragic events of September 11, 2001, redirected the Department's Criminal Intelligence Unit to focus on the probability of future terrorists threats in Fairfax County. Due to **Detective Comfort's** years of experience and knowledge, he was selected to become an essential member of the intelligence unit. This function grew to be an element of the National Capital Regional Intelligence Center (NCRIC). The NCRIC exists to prevent, deter and investigate local terrorism.

Many of **Detective Comfort's** efforts are classified, but one recent case history was released to the public in 2003. In a joint operation with federal investigators, **Detective Comfort** was solely responsible for obtaining the legal means to collect incriminating evidence to prosecute the members of the Virginia Jihad terrorist organization. This group was in the process of acting to support Taliban efforts in Afghanistan. Several members had already received training in Pakistan. Unfortunately for this group, they chose to operate in Fairfax County. They are now serving various prison sentences.

**Detective Comfort**, as a testament to his knowledge and skill was featured in an article in *The Prosecutor* magazine titled, "Using the Elliot Ness Strategy against Terrorists." This six page feature article discusses why **Detective Comfort's** methods are an effective way to disrupt international terrorist organizations. Prosecutors are not the only professionals to benefit from Detective Comfort's experience. In the last three years he has taught over two thousand students in counter terrorism techniques. This accomplishment alone is worth recognition. It is for all these efforts and his personal commitment that he is awarded the Law Enforcement Commendation Medal from our Chapter--**We are proud to present this award!!**

Whether helping a new applicant or working on a supplemental, sometimes we find a person the right age to be a patriot, but cannot prove service. One approach is to look beyond the military service and rendering material aid to other acceptable services that are often overlooked. These include:

- Signing petitions addressed to and recognizing the authority of the provisional and new state governments.
- Civil service under the Colonies from April 19, 1775, to November 26, 1783, inclusive
- accepting obligations or acting under direction of the provisional and new state governments

Civil service includes not only serving in lofty positions such as governor or delegate to a Continental Congress, but serving as a constable, sheriff, or town clerk. Acting under the direction of the provisional or new state government includes work mandated by the counties and towns within a state. Such activity as work on public roads, serving as a juror, appraising estates, laying off dowers for widows, collecting taxes, and overseeing elections is all valid service.

## Robert Hathaway, Warren, MA

Compatriot **Jack Sweeney**, 4<sup>th</sup> great grandson of **Robert Hathaway** organized and conducted his grave-marking and registration in Warren Massachusetts. He had assistance from the SAR Chapter in MA.

At the age of 14 ½ years Robert enlisted in the American Colonies' Army of the Revolution further assigned to the Rhode Island Regiment. He served for 15 months and after about two months at home volunteered again, this time for a year in the Rhode Island Regiment. His unit participated in several battles with the British.

Following his second Continental Army enlistment, Robert performed militia service and he responded to several alarms, but by 1780 the war had intensified in CT, NY, NJ, VA, Carolinas and GA. Robert was discharged as an 18 year old veteran in 1780.

Robert lived a long time, had with **Susanna Hill**, eleven children (six living to adulthood). He died in 1852 at the age of 89 years five months. Few if any thought of his long ago service in the Army of the American Revolution. His death record lists him as a farmer and no notation of military veteran service. Cause of death, was listed as "old age".

Until 2007, Robert's grave in Pine Grove Cemetery had for over 155 years been unrecognized or recorded as that of an American revolutionary War veteran. **Robert Hathaway** is a Forgotten Patriot and by definition is a patriot that no one has ever applied for membership in the SAR or DAR or C.A.R. based on descent from that individual.

## Conrad Solt, Palmerton, PA

Conrad's family gathered around his bedside in 1825 to say goodbye to the patriarch. He had been a sergeant in the PA militia guarding against Indian attacks. Nearly 182 years later four of his direct descendants stood with several other guests to honor Conrad's memory.

Compatriot **John Sinks'** descendant **Frederick Nagel** was the brother-in-law of **Conrad Solt**. **John Sinks** contacted the **Solt family** and they agreed to a ceremony Aug. 4, 2007.
