"In 1780, the Virginia Assembly passed "An act procuring a supply of provisions and other necessaries for the use of the [Continental] Army". This act authorized the Governor of Virginia to appoint commissioners in each County to acknowledge receipt of donated materials and services for later

reimbursement. Under the provisions of this Act, and as a resident here in Loudoun County, the then twenty-year old and recent College of William and Mary student Richard Bland Lee donated 223 pounds of beef to help feed the Revolutionary Army."

#### CROSSING OF THE DAN

The "Retreat to the Dan" began in January 1781, following an American victory at Cowpens in South Carolina and became a "Race to the Dan" across North Carolina and into Virginia. The race was won by General Nathanael Greene with his "Crossing of the Dan" on February 14th at Irvin's and Boyd's ferries on the Dan River.

saved the American Southern Army and was one of the turning points in the war. The historical significance of the event places the Dan River crossing on a unique list of landmark sites of the American Revolution.

#### **GUILFORD COURTHOUSE**

The Battle of Guilford Courthouse was a turning point in the British southern campaign during the American Revolutionary War. Fought on March 15, 1781, General Cornwallis led his troops against General Nathanael Greene in what is now Greensboro, North Carolina. While the battle was technically a blow to the American forces, who retreated from the battlefield, the win cost the British dearly in men and morale. Charles Fox, a British statesman remarked of the battle that, "Another such victory would be the ruin of the British army." The National Park Service maintains the

battle site as well as a museum Resolves as well as the Midand monument dedicated to the Atlantic District. battle.

Each year, the Park Service hosts a day of activities that includes reenactments and ceremonies commemorating the American victory and the Patriots that fell there. Historical organizations gather on this day to participate in a ceremony that pays homage to the sacrifices of our ancestors. This vear's observance occurred on March 17th, 2012 in Greensboro, North Carolina. The Virginia Color Guard was present. Vice President General Larry McKinley participated and laid a wreath on behalf of Fairfax

Bob is an active board member of the Virginia Homicide Investigators Association and serves as their training director. He teaches at the police academy and surrounding police academies and is consulted by detectives from up and down the East Coast.

#### DR. JOSEPH WARREN MEDAL





Joseph Warren, a Boston doctor, was the orator selected to commemorate the anniversary of the Boston Massacre. Because the orator would be heckled by unforgiving British officers and sympathizers, Warren bravely presented his speech with a steady and firm voice. Warren's stirring oratory skill recruited more patriots and moved others to support the Revolution.

The Rumbaugh Orations Contest's National level awards are not currently competitive among nationwide contests, and the national Youth Activities Coordinator (Compatriot Larry McKinley) and the Orations Committee are seeking to rectify this with an enhancement to the current endowment. Significant financial support is required annually to operate the orations contest. The goal of the committee is to increase the national award to \$30,000 annually. This represents awards given to 1st, 2nd, and 3rd place contest finalists and recognition to all national competitors. The current disbursement is \$11,000 annually.

A donation of \$250 or more will be recognized with the standard and miniature sized medal set, and donations of \$1,000 or more will be recognized with a campaign bar for the standard medal.

The medal features a picture of Dr. Joseph Warren, with a quote from his Boston Massacre oration, and is suspended from a blue, gold and white drape.

Donations of any amount will help support the growth of the endowment and can be sent to Larry McKinley.
